<p>This service will be made available to customers that contract for the installation of an Automatic Transfer Switch (ATS) at the customer's site. The Company reserves the right to deny service to customers for situations in which the installation of this ATS would negatively impact the reliability or safety of the distribution system and/or other customers.</p>	
<u>MONTHLY CHARGE</u>	
<p>Option 1. Initial payment of the installation cost of the ATS. Installation costs shall include transporting, installing, and connecting electrically the ATS and the associated pit plus the capital costs of the ATS and other required associated equipment plus:</p>	
R	\$230/month charge.
<p>Option 2. No Initial payment plus:</p>	
R	\$667/Month
<u>Terms & Conditions</u>	
<ol style="list-style-type: none"> 1. Customers shall be required to sign a contract with a minimum term of 3 years. 2. Service under this agreement does not include an uninterruptible power supply. With the loss of the normal electrical supply, the ATS will take approximately fifteen seconds before the customer is transferred to the secondary source of electrical supply (if available) short duration outages may also be experienced due to momentary outages (ranging from one cycle to several seconds) on the Company electric distribution system. The Company shall not be liable for any loss, injury or damage resulting from interruptions, deficiencies or imperfections of service not due to willful default or negligence on its part. Customers requiring a higher reliability of service shall make arrangements for their own uninterrupted power supply. 3. The Company will maintain the ATS with standard Utility Maintenance Practices. The Company shall be held harmless for any damages arising from operations of the ATS or the ATS failing to operate.

- N 4. The charges contained in this tariff sheet are based upon the Company's
N standard ATS, a 600 amp (source side) switch. Should a different ATS be
N requested by the customer, or special conditions require the Company to
N install other than standard equipment and/or use non-standard installation
N methods, the customer shall pay the cost difference of the actual
N installation vs. a standard installation as an up-front special facilities
N payment as defined by the Company's Extension Rules and applicable
N additional maintenance fees. The customer shall not be liable for the
N additional costs of a non-standard switch if installed for company
N convenience purposes.
- N 5. The Company reserves the right to disable the ATS to perform maintenance on
N the ATS or the distribution system. The Company will attempt to minimize
N the number of hours and occurrences of disabling the switch. The Company
N may have the ability to perform additional switching to maintain the two
N feeds. In these situations, the customer may be offered the opportunity to
N pay the Company's costs to provide the additional switching on a time and
N material basis.
- N 6. The ATS is intended to provide an increase in distribution reliability.
N The Company reserves the right to disable the ATS during generation system
N emergency situations such as rolling black outs.
- N 7. For customers who choose the Option 1 payment plan, the Company will repair
N and replace the switch as required for a twenty year period. After the
N switch has been installed for a period of twenty years, the Company will
N continue to perform maintenance on the switch, however should a new switch
N be required, the customer would be required to pay the costs of a new
N switch as an up-front special facilities payment or take service under
N option 2 and pay the applicable monthly fees. The Company reserves the
N right to determine if a new switch is required.
- N 8. A portion of the monthly fee will be waived in instances where the ATS is
N not operational due to malfunction of the switch for a period in excess of
N two weeks at one time. **The monthly charge shall be prorated to reflect the
N time in excess of two weeks that the ATS is not operational and charges are
N not applicable.**
