Service under this schedule provides for generation of renewable energy into the Company's system and not for the actual delivery to the Customer.

A Customer, which is defined by tax ID for non-governmental entities or a single unit of government (e.g., municipality, county, school district, etc.), with multiple accounts eligible for the Renewable Pathway pilot program, may aggregate any of its eligible accounts under a single subscription. The details regarding aggregation and billing will be addressed in the service agreement. Under no circumstances will multiple customers be allowed to aggregate eligible accounts under a single subscription.

This pilot program has a maximum participation limit ("MPL") of 40 MWac of existing customer load and no limit if the customer's load applicable to this pilot is new to the Company's system at the time of entering in to a service agreement. In the event that program participation exceeds 75% of the MPL, the Company will solicit eligible customers to determine if the MPL should be increased. If sufficient commitments are made during the solicitation, the Company will request a higher MPL from the Commission.

N Subscription Size

Subscriptions may be elected in 100 kWh / month blocks with a minimum monthly subscription threshold of 1,000 kWh. For existing customers, the annual total of the subscription (kWh/year) shall not exceed 100% of the average annual electrical usage at the premise(s) of the Customer as measured from a recent twenty-four month period.

Subscription Price

Each billing month, the Renewable Pathway price associated with the subscription period length chosen by the Customer will be applied to the Subscription Size chosen by the Customer. The cost to the Customer for participating in Renewable Pathway will appear on the Customer's retail electric bill as a separate line item consisting of the Net Price per kWh as set forth below.

Pricing is based on the resource cost, administrative and marketing costs, distribution line loss adjustments, other miscellaneous adjustments, capacity credits, and energy credits, as approved by the Commission. The portion of the subscription price based on capacity credits and energy credits shall be based on the Company's average embedded production cost per kWh currently reflected in retail rates, and is subject to change as the average embedded production cost reflected in retail rates changes.

Minimum Charge

Customers will be required to pay at a minimum the charges from the Customer's otherwise applicable rate schedule(s) plus any charges as defined in the Renewable Pathway Service Agreement.

Subscription Renewal

The Company shall provide notification to the subscribing customer regarding automatic renewals, terminations, transfers, or customer renewal obligations 60 days prior to the anniversary date.

One year subscriptions will automatically renew for one year, unless notice of termination is received by the Company at least thirty (30) days prior to the subscription's anniversary date with the same number of per kwh per month blocks of expiring subscription.

Five year subscriptions will not automatically renew upon the completion of the Five Year term. The Company must have receipt of a Subscribers notice to renew its subscription to Renewable Pathway for an additional Five Year subscription or to begin a One Year subscription at its current subscription level or fewer blocks of kWh per month subject to the 1,000 kWh minimum.

Should a One Year or Five Year subscriber provide adequate notice to the Company to increase the number of kWh per month blocks upon renewal of its existing subscription, those additional blocks will be subject to the Renewable Pathway cap noted in the "availability" section of this tariff.

Subscription Transfer

A Subscriber may elect to transfer the Subscription to a new premise of the Subscriber which is in the Service Territory of the Company. Such transfer is not subject to cancellation provided that the Subscriber notifies the Company within 90 days of ceasing to be the customer of record for the premise as described in the Renewable Pathway Service Agreement. In the event that a Subscription based on 100 kWh blocks of the same Size at the new premise would exceed 100% of the average annual usage at the new premise, then the Subscription will be reduced without charge to a level not exceeding 100% of the average annual usage. The Company will provide written or email notice as to the effective date of the transfer to the new Service Address and the new Subscription Size, and this information will be deemed to replace the corresponding information on the Renewable Pathway Service Agreement. In the event of a reduction in Subscription Size due to transfer, no Early Termination Fee as described below shall apply.

Cancellation And Early Termination Fee

All one year subscriptions terminated prior to the completion of the one year term are subject to the Early Termination Fee. In the event the Subscriber provides notice of cancellation due to Force Majeure, the Early Termination Fee shall not apply.

The Early Termination Fee for a One Year subscription shall be equal to the customer's actual Renewable Pathway participation level in kWh for the 3-month billing period ending on the Termination Date multiplied by a per kWh amount of \$0.01 (Early Termination Fee Rate). Any termination by the Customer ahead of the one year term shall be established by notice by the Customer to the Company at least 30 days prior to the Termination Date.

Except as set forth in this Renewable Pathway, all Five Year subscriptions terminated prior to the completion of the Five Year term are subject to the Early Termination Fee. In the event the Subscriber provides notice of cancellation due to Force Majeure, the Early Termination Fee shall not apply.

Any termination by the Customer ahead of the five year term shall be established by notice by the Customer to Ν the Company at least 30 days prior to the Termination Date.

If the Customer does not have at least 6 billing months (five year subscription) or 3 billing months (one year subscription) of Renewable Pathway usage, the anticipated 6-month or 3-month Renewable Pathway usage will be calculated as number of kWh blocks subscribed per month will be multiplied by six (6) for the five year subscription and three (3) for the one year subscription.

This anticipated 6-month or 3-month, as applicable, Renewable Pathway usage will Ν then be multiplied by the Early Termination Fee Rate to determine the value Ν of the Early Termination Fee. Ν

Cancellation by Company

The Company shall have the unilateral right to cancel a Subscription at any Ν time if one or more renewable generation resources supporting the program Ν experiences a Force Majeure event, or for any other reason. Upon cancellation Ν by the Company for any reason other than violation of any of the rules of this Ν Renewable Pathway, no Early Termination Fees will apply. Ν

N Construction and Operations Labor

- 2. Any customer taking service under this rider for a Five year subscription shall execute a Renewable Pathway Service Agreement. The effective date of service under this rider will be set forth in the Service Agreement.
- 3. All terms and conditions apply as stated in the Renewable Pathway Ser Agreement between the Company and the Subscriber for participation in a Five Year subscription.
- 4. All Renewable Energy Credits (RECs) associated with the subscription shall be assigned to the Company on behalf of the Subscriber, and the Company shall retire any RECs associated with a subscription that are tracked in the Midwest Renewable Energy Tracking System (MRETS) program or any similar program on behalf of the Subscriber.
- 5. A customer, which is defined by tax ID for non-governmental entities or a single unit of government (e.g., municipality, county, school district, etc.), with multiple accounts eligible for this pilot, may aggregate any of its eligible accounts under a single Renewable Pathway service agreement application with the Company, up to a maximum number of accounts as determined by the Company on a case-by case basis. The details regarding aggregation and billing will be addressed in the service agreement. Under no circumstances will multiple customers be allowed to aggregate eligible accounts under a single service agreement application.
- 6. In the event the customer uses less energy in a month than the amount subscribed to from Renewable Pathway, the customer is still responsible for payment for the blocks of Renewable Pathway subscribed to.
- 7. A customer may only subscribe to this schedule and the Company's other renewable offerings including the Experimental Renewable Energy Rider, Dedicated Renewable Energy Resource Pilot Program, "Solar Now" Solar PV System Hosting Pilot Program or any future voluntary renewable energy offering, if the total amount of all subscriptions combined does not exceed 100% of the average annual usage at the premise of the Subscriber. If a customer's premise is served by distributed generation resources, the Subscription Size combined with the distributed generation resources may not exceed 100% of the average annual usage at the premise of the Subscriber.

- 10. The Company reserves the right to deny or terminate subscriptions under this tariff to customers in arrears with the Company.
- 11. The Company reserves the right to limit subscriptions due to the availability of renewable energy.
- 12. The Company reserves the right to terminate this program in its sole discretion upon a requisite filing to the Public Service Commission Wisconsin.
- 13. Pilot participation may be limited at the sole discretion of the Company. Additionally, the Company reserves the right to limit customer specific participation on this pilot based on a customer's bill payment and collection history.
- 14. References to the Midcontinent Independent System Operator (MISO) or the American Transmission Company (ATC) shall also refer to any successor organizations.
- 15. Any Customer choosing to be served under this pilot thereby waives all rights to any billing adjustments arising from a claim that the bill for the customer's service would be cheaper on any alternative rate schedule for any period of time, including any rights under Wis. Admin. Code PSC 113.0406(4).
- 16. Customers shall be bound by, and receive and pay for service furnished hereunder in accordance with (i) the rates, terms and conditions of the Renewable Pathway; (ii) the rates, terms and conditions of their otherwise applicable rate schedule(s), (iii) the Company's Rules and Regulations; and (iv) any future modifications of such rates, terms, conditions, and rules and regulations that may be ordered or approved by the PSCW. To the extent that there are conflicts among any of the foregoing, the specific provisions of this pilot shall govern.
