Amendment 802 Schedule BYOD

Residential Service - Bring Your Own Device Pilot**Electric**AVAILABILITY

Optional service available to residential customers on Rate Schedule Rg-1, Rg-3, or Rg-5 with central air conditioners who have installed an approved smart thermostat ("Device") and have agreed to provide the Company with the ability to remotely control the Device in order to reduce electrical demand during high electricity demand periods ("Event"). This program is an experimental pilot program. This experimental pilot program has a maximum subscription limit of 24,000 Devices.

RATE

All deliveries from the Company to the customer will be billed in accordance with the customer's otherwise applicable rate schedule.

Smart thermostat one-time enrollment credit, per customer \$25.00

Central air conditioning participation credit: \$6.25/Device/Mo.*

* Applicable only for service during June, July, August, and September billing months.

DEVICE

For the purposes of this tariff, a Device is defined as a smart thermostat that must satisfy each of the following criteria:

- (1) The Device is compatible and enrolled with the Company's energy management system. A list of compatible devices is made available on the Company's website.
- (2) The Device is owned by the customer responsible for the electric account from which the Device is served.
- (3) The Device is connected to a reliable wireless internet connection.
- (4) The Device meets all other conditions listed in this tariff.

EVENTS

The Company may control the customer's Device in order to reduce electrical demand during high electricity demand periods. Some events may be preceded by a decrease in the customer's thermostat in order to pre-cool the customer's dwelling.

- (1) No more than 20 Events will be called per customer per year.
- (2) An event will last no more than 4 hours.

EVENTS (cont.)

- (3) Customers will be subject to Events Monday through Friday, excluding those days designated as legal holidays for New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, and Christmas Day.
- (4) Company shall, whenever possible, provide a minimum of 1 hour notice to customers prior to the start of an Event and, whenever possible, a minimum of 30 minutes notice for the ending of an Event.
- (5) Customers may opt-out of an event at any time unless the Midcontinent Independent System Operator declares an Energy Emergency Level 2 Alert for the Company's service territory. This mandatory event may exceed 4 hours.
- (6) The Company, in its sole discretion, may remove the customer from this pilot in the case of poor performance, whether the performance in question was intentional or due to equipment malfunction.

CONDITIONS OF DELIVERY

- (1) The Device must control a functioning central air-conditioning system.
- (2) A customer may enroll multiple Devices, but credits will be provided per air-conditioning unit controlled. Customers with multiple air-conditioning units may be eligible for multiple credits. The one-time enrollment credit will be provided once per customer per residence.
- (3) A customer must remain on this rider for a minimum of 12 months, starting with the first full billing month after enrollment in this pilot.
- (4) Customers will start service under this rate schedule at the beginning of their next billing month following the installation of all Company and customer equipment necessary to receive service under this rate schedule.
- (5) The customer must have wireless internet service.
- (6) The customer agrees to participate in occasional testing of load management capabilities of the Device.
- (7) Only customers in good standing (i.e., who have had no delinquent electric bills or disconnections in the past 12 months) will be eligible for this tariff.
- (8) Pilot participation may be limited at the sole discretion of the Company.
