<p>1. <u>EFFECTIVE IN</u>: All territory served.</p> <p>2. <u>AVAILABILITY</u>:</p> <p>A. Service under this schedule is available to any customer that meets all of the criteria of Sections 2.A.1. through 2.A.5. below:</p> <ol style="list-style-type: none"> <li>1. The customer has substitute fuel services available that can be economically installed and utilized.</li> <li>2. The customer provides evidence showing the actual viability of the substitute fuel services via an economic evaluation submitted through the Company to the Commission.</li> <li>3. The customer and the Company have negotiated a contract with a negotiated distribution rate that is filed with the Commission. The negotiated distribution rate must be compensatory, as defined in the Commission's order in docket 05-GI-108, Phase I, and of sufficient amount to recover the appropriate contract term incremental costs. The negotiated distribution rate will have a ceiling no higher than the embedded costs.</li> <li>4. The contract term incremental costs will be defined as the extra, or additional, costs of serving the volumes of gas during the proposed term of the contract, including but not limited to the incremental costs of:                     <ol style="list-style-type: none"> <li>a. Metering site investment revenue requirements (capital and O&amp;M),</li> <li>b. Meter Reading and bill issuance,</li> <li>c. Customer Service personnel,</li> <li>d. Odorization,</li> <li>e. Safety related operations (valve inspections, leak detection, etc.)</li> <li>f. System reinforcement avoidance.</li> </ol> </li> <li>5. The contract term shall be no more than 5 years, unless a longer period is approved by the Commission.</li> </ol>

3. <u>RATES:</u> The rates for this service are as follows:	
<u>Daily/Monthly Charges Per Meter:</u>	
A. <u>CUSTOMER CHARGE OR LOCAL DISTRIBUTION SERVICE FIXED CHARGE:</u>	
1. If specified in the individual contract, the monthly Customer Charge, monthly Local Distribution Service Fixed Charge or the daily equivalent will be the amount specified in the individual contract.	
B. <u>RATE PER THERM - All Therms</u> - Rate per the individual contract.	
C. <u>OTHER</u> - The customer shall pay all charges as specified in the individual contract and/or this rate schedule.	
4. <u>PURCHASED GAS ADJUSTMENT CLAUSE:</u> Therms billed the Take-or-Pay rate are subject to the Purchased Gas Adjustment Clause.	
5. <u>MINIMUM CHARGE:</u> The monthly minimum charge is the Local Distribution Service Fixed Charge or Customer Charge.	
6. <u>SPECIAL RULES:</u>	
A. Except where specifically modified by this rate schedule or by contract, the Company and the customer are bound by all rates, terms and conditions of rate schedule GT.	
B. Customers taking service under this rate schedule are also subject to the following rate schedules: Definitions, Municipalities Served, Service Data, Customer Attachment, Enlargement & Curtailment Procedure, Purchased Gas Adjustment Clause, Service Rules and Extension Rules.
